Rectification

The president of the "Association Française des Vétérinaires d'Endurance Equestre" ist Mme Agnes Benamou-Smith and not Mme Céline Robertas published in newsletter 02-04. Sorry.

<u>Sanctions in France</u>

Since the beginning of 2003, the French Equestrian Federation has started to sanction endurance riders and horses for eliminations.

<u>Criteria</u>

Rider:

has to re-qualify (2 CEN* of 90 km each to be allowed to re-start at CEI** level and 1 CEI** to be allowed to re-start at CEI*** level) in the following cases:

- one elimination for metabolic reasons with report from the President of the Veterinary Commission (co-signed by the President of the Ground Jury)
- three consecutive eliminations with the same horse during a period of two years
- five eliminations during one season (if there are more eliminations than completions)

Horse:

- 6 12 months of rest after one elimination for metabolic reasons with report from the President of the Veterinary Commission (co-signed by the President of the Ground Jury)
- 6 months of rest after two consecutive eliminations for metabolic reasons during a period of two years
- 6 months of rest after three consecutive eliminations for any reason during a period of two years
 - > 8 riders and 18 horses have been sanctioned in France during or after the season 2003.
